Approval of Minutes:

Treasurer's Report:

Total income for December was \$1,402.76, more than half of which came from Barnes & Noble gift card-book fair in the amount of \$789.50. Tips earned from Barnes & Noble gift wrap were \$50.36. Regular book sales were \$425.39. Pencil sales were \$6.25. The expenses were \$57.51 for flower/gift/contributions and \$761.50 for special events. The year-end assets were \$13,794.84.

A question was raised about the profitability of the sale of pens and pencils. The library likes the convenience for patrons so we will continue to sell them.
